Welcome to the new digital entry form for the NECCC Print Competitions. This form is designed to eliminate the duplicate data collection required across the paper forms. This form does not change the process of mailing the paper forms and prints to the host club for every competition.

What's New

- Enter your club information once and it automatically appears every place required
- Enter your print information once and it automatically appears every place required
- An entry label form for the back of each print is automatically generated

New steps

- The technology used is an Adobe Acrobat (PDF) document with embedded live forms. You will need to save a copy of this PDF document on your PC/device that you then reuse for each competition.
- In addition to mailing the printed forms, the saved PDF document will be emailed before each competition.
- Print and attach the automatically generated labels to the back of your prints

2. Open the saved PDF document in Adobe Acrobat or a web browser
3. Complete the Master Record on page 2
4. Save, Print and Mail the Master Record with a check to Arthur Vaughan

How to save an Adobe Acrobat (PDF) form

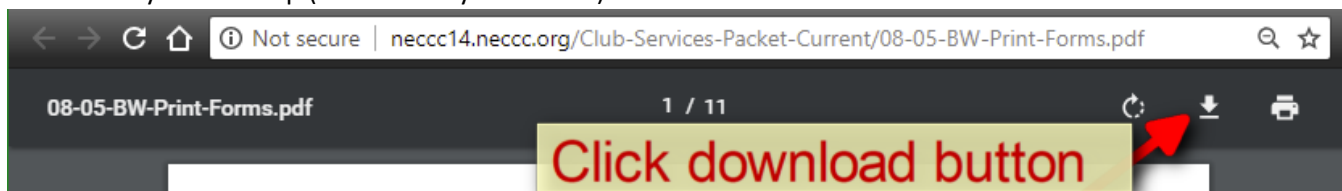
Saving any PDF document is dependent on the software you are using to enter data into the form. Here are a couple examples. **Recommended choice:** use the free Adobe Acrobat Reader which is available from <https://get.adobe.com/reader> (hint: unselect all optional offers before download). Do not use Photoshop since Photoshop discards the form information when opening any PDF document.

Adobe Acrobat Reader (free at <https://get.adobe.com/reader>)

1. File-> Open this URL <http://neccc14.neccc.org/Club-Services-Packet-Current/08-05-BW-Print-Forms.pdf>
2. File -> Save As ... (choose your favorite location, e.g. Desktop)
3. Open (if needed), File -> Open... wherever you saved the file
4. Enter data on page 2 and page 3 only, save, print, ...

Google Chrome

1. Browse to <http://neccc14.neccc.org/Club-Services-Packet-Current/08-05-BW-Print-Forms.pdf>
2. Save file to your desktop (or folder of your choice):



3. Opening the file in Chrome can be tricky since the default app for opening any PDF document is probably not Chrome. In Chrome enter the path to the document, e.g. on Windows <file:///C:/Users/<your user name>/Desktop/08-05-BW-Print-Forms.pdf>
4. Enter data on page 2 and page 3 only, save, print, ...
5. To save from Chrome, Print and choose the destination of "Save as PDF" and Chrome will ask you where to save the PDF document.
