MEMORIAL FUND

The Memorial Fund was proposed many years ago, in 1969. It was approved by the Executive Committee and a sum of money was transferred from Council funds to establish the fund. The income from this fund was to be used to provide scholarship grants to needy and worthy students. Please note the companion sheet in this packet which concerns scholarship awards. If you know of a qualified student that fits the parameters of eligibility for a scholarship please give them the forms to fill out and submit to the appropriate committee.

Charitable Giving Options

The New England Camera Club Council, Inc. was established in 1937, and incorporated in 1963. NECCC is a charitable, tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code. Gifts and donations are tax-deductible to the extent allowed by law, and will be acknowledged both individually and in the NECCC Bulletin. Donations help NECCC continue its work to support photography and photographic education throughout the New England region. There are two means of making a supporting gift to NECCC.

General Operating Fund

Donations to the General Operating Fund support the programs, services and activities that NECCC provides to member camera clubs throughout New England. These services include assistance in locating judges or programs, recorded lectures and commentaries, interclub competitions, and the NECCC Bulletin to name a few. The Officers, Directors, and Service Coordinators of the Council are all unpaid volunteers. Even then, the cost of providing the services offered to member clubs significantly exceeds the nominal annual dues.

Donations to the <u>General Operating Fund</u> may also be made "In Memory Of" someone or to acknowledge someone who has provided an exceptional presentation or service to a club or the Council.

Memorial (Scholarship) Fund

The Memorial (Scholarships) Fund is restricted to NECCC's support of continuing education. Each year the Council awards scholarship grants to deserving students pursuing a career in photography or a related field and enrolled in a photographic curriculum in an accredited institute of higher learning. NECCC's goal is to encourage and foster the pursuit of photography and its related fields as a career avenue by providing financial support to help aspiring students to afford the ever-increasing cost of higher education.

<u>Gift Giving</u>

A donation or gift to NECCC helps further the goals of NECCC: to provide scholarship grants to students and to support New England camera clubs through various programs and services that are offered to member clubs.
